# **Privacy policy**

# **Overview**

This policy sets out the rules for the collection, processing and use of personal data obtained from you by the **partners** of the Educate4Green project.

### Data Collection and Use

#### Use of your personal information

Personal information submitted through our website may be used for the purposes specified in this policy. We may use your personal information to:

- sending expressly requested notifications by e-mail;

Except as provided in this policy, we will not provide your personal information to third parties.

# **Retention of personal information**

We will keep documents (including electronic documents) containing personal data:

- 1. to the extent that we are required to do so by law;
- 2. if we believe that the documents may be relevant to any ongoing or future legal proceedings;
- 3. to establish, exercise or defend our legal rights (including providing information to third parties for the purposes of fraud prevention and credit risk reduction);

#### Security of your personal information

- 1. We will take reasonable technical and organizational precautions to prevent the loss, misuse or alteration of your personal information.
- 2. We will store all personal information you provide on our secure (password and firewall protected) servers.
- 3. You acknowledge that the transmission of information over the Internet is typically insecure and we cannot guarantee 100% security of data sent over the Internet.
